# SUMMARY AND PRECIS WRITING

Precis writing and summarizing are both processes of condensing a longer piece of text into a shorter version, but they have some differences in terms of purpose, length, and approach.

### 1. Purpose

- Precis Writing: The primary purpose of precis writing is to capture the essence of the original
  text while maintaining its core ideas, tone, and style. A precis typically focuses on conveying the
  author's main points and arguments.
- Summarizing: Summarizing also aims to condense the information, but the emphasis is on
  presenting the main points in a concise form without necessarily preserving the original style or
  tone.

#### 2. Length

- Precis Writing: A precis is generally a very condensed version of the original text, often reduced to one-third or one-fourth of the original length. It requires careful selection of words to convey the meaning effectively within a limited word count.
- Summarizing: Summaries can vary in length, but they are generally shorter than the original text. The length of a summary depends on the purpose and context, but it is typically more flexible than a precis.

### 3. Detail and Style

- Precis Writing: A precis aims to retain the nuances of the original text, including its style, tone, and specific details. It requires the writer to carefully choose words and phrases that capture the essence of the original while maintaining clarity.
- Summarizing: Summaries focus on conveying the main ideas and essential information, often
  omitting specific details, examples, or stylistic elements present in the original text. The
  emphasis is on brevity and clarity.

#### 4. Process

- Precis Writing: The process of writing a precis involves a more meticulous approach. It requires
  careful reading of the original text, understanding its core ideas, and then rephrasing and
  condensing those ideas while preserving the author's voice.
- Summarizing: Summarizing involves identifying the key points and main ideas of the text and
  presenting them in a condensed form. It may involve omitting less crucial details and
  restructuring the information for clarity.
